She was Chairman of the Board of Directors of Santo Antônio Energia from 2022 to 2024, of Chesf from 2019 to 2023 and of CGT Eletrosul from 2019 to 2022.

She was one of the leaders of the recovery and privatization of Eletrobras, which took place with the Global Public Offering of Shares, in the amount of R\$ 33.7 billion, in June 2022.

She held the position of Executive Director of Planning and Control at Neoenergia S.A. from 2013 to 2016, as well as the position of Director of Planning and Control and/or Board Member in its subsidiaries.

She was a Fiscal Council Member of Norte Energia from 2015 to 2016.
