Experience in energy sector

His experience is mainly linked to the regulation and management of the Spanish and European energy sector during his tenure as Minister of Industry and Energy (1993-1996), when he promoted a restructuring of the energy sector in Spain and liberalization of the sector legislation, also boosting renewable energy and the first European Union guidelines for the creation of the single electricity market. His work in this field continued through his attendance in energy sector seminars, publication of several articles on energy policy and his contribution to the collective work on energy regulation.

Juan worked as an Officer at PROMEK SL, a company in the automotive sector, in addition to being a member of the Advisory Boards of the Siemens companies, a company in the engineering sector, Capgemini, a company in the technology sector, Futurespace, a company in the technology sector, and Eptisa, a company in the engineering sector, in addition to having acted as economic advisor for Arco Valoraciones SA, a company in the real estate-financial sector.

He had a long public career as a Counselor to the community (Ayuntamiento) of Bilbao, Representative of the Province of Bizkaia, Representative in the Parliament of the Basque Country Autonomous Community, Government Deputy in the Region of Murcia and, later, in the Basque Country, Congressman in the Spanish Congress, Minister of Public Management and, afterwards, Minister of Industry and Energy.

He was also an Ideas Laboratory Director at Fundação Alternativas, an independent think tank dedicated to social, economic and political reflection, and chairman of the NGO Alliance for Solidarity, dedicated to cooperation for development.
